EAST PITTSBURGH COUNCIL MINUTES April 21, 2020

The April 21, 2020 meeting of the East Pittsburgh Borough Council was called to order by Mary Carol Kennedy at 7:01 p.m. via video teleconference.

PUBLIC COMMENTS

Public comments were solicited to be submitted via mail or email. No comments were received.

ENGINEERS REPORT

Mr. Gilliland report is on file. He reported the CITF paving project is pending approval for construction activities to begin. Linden Mall project, pre application was submitted through the ALCOSAN GROWS. GEDTF grant was also submitted for reconstruction of the steps in the borough and an application to the GTRP for the playground on Trax Alley. The GTRP application is estimated for a project cost of \$130,000 and a grant request of \$110,500, with 15% match (\$19,500) coming from the borough. The borough will be applying to US Steel to cover the matching funds.

1. Motion to approve application to GTRP for \$110,500 made by Earnest Frazier and Second by Jonathan Reyes. Vote was unanimous to approve the application.

Inspections were completed on the steps from Rt. 30 to Linden Ave, Prospect to Braddock Ave, and from Sunnyside to Quarry Field. The GEDTF application is for \$200,000. This would be to ratify a resolution to apply for this project. This does not include emergency repairs to make the steps safe for travel such as steps that are missing.

Immediate repairs for safety were presented for the section between Rt 30/Linden and for Prospect/Braddock.

Mr. Abrams asked for clarification about the ability to make repairs to the steps at 700 Grandview vs. replacing them. Mr. Gilliland stated that a cap would be possible, and that he would report a price for that, which would be less expensive than a replacement.

- 2. Motion to approve \$20,675 to make immediate repairs to the steps from the General Fund made by Jonathan Reyes and seconded by Stacey Simon. Roll call vote was unanimous in favor. Motion passed.
- 3. Motion to approve application to the GEDTF fund in the amount of \$200,000 to complete long term repairs to the steps between Rt 30/Linden Ave and Prospect/Braddock Ave. made by Stacey Simon and seconded by Earnest Frazier. Roll call vote was unanimous in favor. Motion passed.
