Mr. Frazier asked if the other Mon-Valley communities were in favor of restricting oil and gas development. Ms. Simon and Ms. Kennedy both indicated that each municipality is a little different and that the residents appear to overwhelmingly oppose fracking.

Mr. Reyes referenced the recent report from the State Attorney General which recommends additional setbacks in excess of the ones proposed by the Ordinance.

Mr. Abrams conducted a roll call vote to approve the Ordinance as advertised.
