General Updates

While the world feels like it is in a COVID-19 standstill and some of you may have forgotten what day it is, the Borough staff have been hard at work all summer. We would like to take this opportunity to highlight what has been accomplished since the Shamrock came back into print last year to make the government more effective and improve the borough.

- Infrastructure—
 - Updated the Borough Code and placed it on-line for easier access.
 - Paved .665 linear miles of the roads (15%) in the borough.
 This does not include the re-paving of the 100 & 200 blocks of Bessemer Ave. by People's Gas.
 - Began a process to track and prioritize road resurfacing.
 - Added voluntary recycling at the Community Center.
 - Improved overall data collection for long term planning.
 - Continued trapping of vector wildlife such as skunks and groundhogs.
 - Planned repair of the steps leading from Grandview Ave to Linden Ave.
- Blight-
 - Submitted a grant to assist with marketing vacant properties to be purchased before they require demolition.
 - Demolished 7 homes that posed a danger to neighbors in 2020.
 - Received a grant to demolish approximately 3 homes (to be done in 2021).
 - Increased monitoring and enforcement of quality of life ordinances such as property maintenance.
 - Began a banner program to show pride in our borough.

Traffic Concerns

Most residents are aware of a motor vehicle accident that occurred in July where a child was struck by an oncoming car. Because of this accident and ongoing concerns the borough obtained a radar trailer to monitor speed and to begin the necessary steps that would be involved to add traffic calming measures to the road. Traffic calming is the term

used for placing physical barriers on the roads or curbs to slow traffic. Among these are speed humps which cause a vehicle to "bounce" when approached at a fast enough speed.

PennDOT and State

laws control traffic calming. Formal traffic studies need to be conducted and submitted to PennDOT, including any history or patterns of accidents/injury. This is not a local decision.

Over the past 3 weeks the borough has been monitoring traffic counts and speed using the radar trailer. After analyzing the data and looking at the histo-

ry of accidents, it has been determined that PennDOT would not approve any traffic calming devices for Bessemer Ave.

All of us would like for our children to be safe and comfortable playing in front of our homes where we can monitor them.

The decision to not pursue speed humps did not come easily and it does

not mean that we will not continue to seek alternative ways to effectively stop drivers from speeding on any of our roads.

In addition to seeking alternative measures, we hope that further development of Besse-

mer Avenue and the planned addition of a playground on Trax Alley will increase foot traffic which has a natural effect of slowing drivers.

Until we can all be safe; stay vigilant, stay aware, and stay active.



Construction Projects -

The following projects will be occurring in May and beyond:

- Milling and repaving Rt. 30 from Forest Hills to intersection of Rt. 48 (now through December)
- Milling and paving of Christina Alley from Grandview Ave to Main St.
- Milling and paving of Wood Alley from Western to Draper
- Milling and paving of Franklin Ave from Grandview Ave. to Main St.



- Milling and paving of the 100-200 blocks of Bessemer Ave from the gas line replacement—complete
- Urgent repairs to the steps leading from Grandview Ave, under Rt 30 and to Linden Ave.
- Urgent repairs to the steps leading from Prospect Ave to Braddock Ave.

Code Enforcement and Public Safety Vacant Lots

Recently people have been parking vehicles on vacant lots within the borough. Many of these lots are maintained by the borough while they wait for a new owner. Parking on private property is a violation of Borough rules and inhibits our ability to maintain the land. Any vehicles found parked on borough maintained lots that are not designated for parking will be **tagged and towed at the owner's expense.**

Trash Reminders

Section 58.2 of the Borough Code (Ord. 735, amended Ord. 826) states that all garbage and rubbish is required to be stored in an approved garbage container with a properly fitted lid. Lids are required to keep out rodents and other foraging pests away from our homes – an open trash can is an invitation for food.

No garbage or rubbish is permitted to be stored outside unless it is in the garbage containers (this will help keep down the rodent population). (Section 58.66.4.1)

No garbage containers are permitted to be placed along the roadway or alley until the night before garbage pick up, which is Wednesday evening after 6:00pm. (Section 58.1) The only time this changes is during a Holiday, which will back garbage pick up one day.

Parking Chairs and Handicap Parking

Parking on Borough streets is limited. In an effort to improve the situation we are collecting updated handi-



cap parking information. Due to this effort we have been able to remove some signs and free up parking for all residents.

We ask that as neighbors and residents that you **not reserve** parking spaces with chairs, buckets or any other items. Beginning in September Borough staff will be removing these items from the road. An exception will be made during significant snow if you have shoveled out a parking place.
