# EAST PITTSBURGH COUNCIL MINUTES April 19, 2022

The April 19, 2022 meeting of the East Pittsburgh Borough Council was called to order by Mary Carol Kennedy at 7:01p.m.

- 2. A motion to approve the Slums and Blight resolution for the structure at 506 Bessemer Ave, as a part of the County Act 152 application.

#### **PUBLIC COMMENTS**

Delthene Herbert, 429 Howard St. Ms. Herbert voiced concerns about abandoned cars in the vacant lot (borough owned) on the corner of Main St. and Isabella Alley, next door to 811 Main St. Concerns were also voiced about drug use taking place in the lot. Ms. Herbert noted concerns with trash at the home next door (427 Howard) that date back to 2020 and that residents place their trash out earlier than allowed. Ms. Herbert's final concern was that there are commercial trucks parking on the street and knocking down lines. The types of lines knocked down and when was not specified. Ms. Herbert submitted pictures and copies of some emails. Council discussed the possibility of prohibiting all parking on the vacant lot.

Council engaged in further discussion regarding trash and overall violations in the Borough. Frustration was voiced that the Magistrate will not hold hearings for defendants who do not respond and has a string history of "not-guilty" findings if the code violation is resolved prior to the hearing. Mr. Evashavik recommended that Council send a letter to the Magistrate and request a meeting to explain the negative consequences to the Borough based on his rulings.
