PUBLIC COMMENTS:

- 1. **State Representative Abigail Salisbury:** Introduced herself to Council as the State Representative for the district on her journey to attend meetings across the municipalities that she represents. Rep. Salisbury updated Council on the list of grant opportunities and that a printed book would be on its way soon. Rep. Salisbury additionally notified Council on the criminal history expungement clinic aimed at relieving the professional burden on qualifying individuals with a criminal history. She further identified a grant writing training and education seminar for nonprofit organizations and local governments at 10:00 AM until 4:00 PM, on October 12th.
- 2. **Mr. Jan:** with support of others in the room, this concerned resident asked for codes pertaining to pedophiles living in the Borough and asked whether the members of the community or the Borough leadership could prevent residence or remove current residents with such a background.
- 3. **Alicia Banks:** a resident living on Howard street issued a complaint regarding her alley, and Mr. Jan voiced similar concerns about the paving of the alley behind her property. She additionally reported that a neighboring property was being utilized unlawfully in accordance with the Borough Ordinances and claimed that the property owner admitted to

such use. The Borough Manager was requested to email information regarding the Borough's ordinances and the upcoming Listening Session on September 28, 2023.
