A Blight Strategy Booklet was provided to all council members explaining step by step procedures for eliminating blight. Some recommendations from the study where:

- a. Form a Blight Committee to meet on a regular basis.
- b. Have regular Code Enforcement inspections of the properties.
- c. Take one property at a time to work on.
- d. Find properties in strong neighborhoods that would be worth rehabbing.
- e. Keep your website, maps, and newsletters updated.
- f. The Land Bank and the MVI are also available to help.
